



## **GRADUATE APPLICATION FOR FINANCIAL AID Summer 2021**

### **Pre-registration:**

Summer Pre-registration will be held on Monday, April 19 and Tuesday, April 20. All students are strongly advised to pre-register for all summer courses.

### **Types of Graduate Financial Aid Available:**

- Graduate Scholarships
- Federal Unsubsidized Direct Loans
- Federal Graduate PLUS Loans

### **To Receive Funds:**

In order to receive financial assistance at Millsaps College you must be admitted to the college as a degree-seeking student. To be considered for loans, you must enroll in at least **6 hours** of class work over the course of the summer.

- Federal Direct Loans have an annual maximum limit of \$20,500 (academic year consists of fall 2020, spring 2021, summer 2021)
- If Direct Loan limit has been met, a Federal Graduate PLUS Loan application can be completed at [studentaid.gov](http://studentaid.gov) to determine eligibility

### **Millsaps Study Abroad:**

For Millsaps Study Abroad programs, loan fund credits to your Millsaps student account will not be made until the actual term begins and we receive verification of enrollment.

### **Steps for application:**

- Complete, sign, and return this summer application to the Office of Financial Aid

  - Bring to Office of Financial Aid/Sanders Building/Second Floor
- If you intend to use federal loans, complete the 2020-2021 Free Application for Federal Student Aid (FAFSA) if you have not previously completed it
- Pre-register for your courses on April 19 or 20
